WHAT IS MALAYSIA MY SECOND HOME (MM2H) PROGRAMME

什么是马来西亚第二家园计划

1. **Malaysia My Second Home (MM2H) Programme** is a programme promoted by the Government of Malaysia to allow foreigners who fulfil certain criteria to obtain multiple-entry social visit pass to stay in Malaysia.

我的马来西亚第二家园计划是一项由马来西亚政府大力推动与支持的一项特别计划，让符合特定条件的外籍人士获得多次入境的社交签证，以便长期居留在马来西亚。

2. Multiple-entry social visit pass valid for 5 years and is renewable.

有效期限为 5 年（并可更新）的多次入境社交签证。

3. This programme open to all citizens from all the countries recognised by Malaysia, regardless of religion, race, gender and age. Spouse of Malaysian who are not citizen of Malaysia and expatriate in Malaysia may apply to this programme upon expired of the employment visa for the purpose of retirement in Malaysia.

这项计划是开放给所有受马来西亚承认的国家公民，且不受种族、宗教、性别或年龄限制; 非马来西亚公民与外籍人士的马来西亚配偶可在工作签证到期后申请此计划，以在马来西亚退休。

4. Principal applicants are allowed to bring their spouse and unmarried children below the age of 21 and parent who are age 60 and above.

5. More than 42,000 participants around the world participated this programme.
